Automatic Entry:

To receive an automatic entry to the sweepstakes, current Spectrum Credit Union members in good standing may visit the Credit Union's "Refer-a-Member" webpage at <u>https://spectrumcu.org/may-referral</u> and complete the new member referral form.

New members who open a Primary Share Savings Account during the Sweepstakes entry period with a minimum deposit amount of at least \$25 will receive an automatic entry. New members do not need to be referred to be entered. Current members who open additional memberships during the sweepstakes period will not receive an entry.
